# Reactions to the New Plan for Immigration: a reading list

### 1. Background

This reading list collates a selection of recent media coverage, stakeholder responses and other background material relevant to the Government's New Plan for Immigration policy statement.

The Government published the policy statement on 25 March. The Home Secretary made a related oral statement to the House on the same day. The proposals outlined in the Plan are open to public consultation until 6 May.

The Plan is largely focused on addressing Government concerns about unfairness and abuse within the current asylum system; illegal immigration; and enforcement of removal decisions. Other proposals concern updating British nationality law and making changes to systems for protecting suspected victims of modern slavery.
