Peerage Creations, 1958–2008

This Library Note presents information on all peerage creations since 1958. In that year, the Life Peerages Act enabled life peerages, with a seat and vote in the House of Lords, to be granted other than for judicial purposes, and for the first time for women to become Members of the House. In the fifty years since the passage of the Act, 1132 such life peers have been created, in addition to 58 new hereditary peerages and 52 Law Lords under the Appellate Jurisdiction Act 1876. This Note provides various statistics showing the numbers of new peers created under different administrations, their gender, age at ennoblement, party affiliation and previous career.

1. Introduction

This Lords Library Note presents detailed information on all peerage creations since the first list of life peers was published on 24th July 1958. It updates earlier Library Notes, the most recent being *Peerage Creations, 1958–2007* (LLN 2007/004, 5th October 2007), to the situation at 24th July 2008. Details of the 58 individuals created hereditary peers since 1958, and of the 52 Lords of Appeal in Ordinary created under the Appellate Jurisdiction Act 1876, are given in addition to information on the 1132 life peers created under the Life Peerages Act 1958. Lords Spiritual are not included, since archbishops and bishops do not remain members of the House of Lords for life (former archbishops or bishops who were created life peers on retirement, however, are included). The 92 hereditary members remaining under the House of Lords Act 1999 are not treated as “new creations”, and thus do not appear in the data in that capacity.

Part 2 of this Library Note highlights some of the key findings from the data. These should be read in conjunction with Part 3, which describes the sources and methods used. For each peer created since 1958 information was collected on their age at announcement, gender, background (main occupation or activity prior to ennoblement, and whether he/she was previously a Member of Parliament), party allegiance (at creation and now or at death), and the circumstances surrounding their creation (the Prime Minister in power at the time of the announcement, and the type of honours list). Some of the problems in gathering information on individual peers from existing sources are highlighted. Part 3 also outlines some of the issues arising from the House of Lords Act 1999 and the establishment of the Appointments Commission, noting how these affect the analyses.

Part 4 presents selected summary tables on peerage creations since 1958. These tables, which exclude peers created under the Appellate Jurisdiction Act 1876, include analyses showing:

- the number of peers created during each Prime Minister’s period in office, by gender, and by age at announcement;
- the backgrounds and party allegiances of peers created during each Prime Minister’s period in office; and
- the backgrounds of peers whose creation was announced in different types of honours list.

Part 5 gives full references for the sources consulted in the preparation of this Note.

Appendix 1 gives details of each peer whose creation was announced after July 1958. The information is given in chronological order by date of announcement of peerage.

Appendix 2 is a chronological list of women peers created since 1958.

Appendix 3 lists the Lords of Appeal in Ordinary created since July 1958 under the Appellate Jurisdiction Act 1876.

Appendix 4 lists those peers nominated by the Appointments Commission.

2. Key findings

- A total of 1242 peerages have been created since July 1958, comprising 58 hereditary peerages, 52 peerages created under the Appellate Jurisdiction Act 1876, and 1132 peerages under the Life Peerages Act 1958 (Table 1).
- Since 1958, there have been on average 24 peerages created every year (excluding Law Lords appointed to serve in a judicial capacity). Since May 1997, there have been on average 36 peerages created annually (Table 1).
- Since 1958, 1044 (84%) peerages have been granted to men, and 198 (16%) to women. Since May 1997, 76% of new peers have been men, and 24% women (Table 1).
- 33% of new peers were aged in their 50s, and 46% in their 60s, at the time of their ennoblement (excluding Law Lords) (Table 2).
- Some 37% of those granted peerages since 1958 were previously an MP or MEP (excluding Law Lords) (Table 3).
- Of the 391 peerages (excluding Law Lords) created since May 1997, 65 were Conservative, 168 Labour, 55 Liberal Democrat, and 103 independent/Crossbench/other at the time of ennoblement (Table 4).
- From 1979 to 1990, there were 205 peerage creations, of which 98 were Conservative, 56 Labour, 10 Liberal/SDP, and 41 independent/Crossbench/other (Table 4).
- With the exception of Edward Heath's administration from 1970 to 1974, each premiership in the last fifty years has seen a greater number of peerages granted to individuals affiliated to the party in Government than to the main Opposition party (Table 4).

3. Sources and methods

A number of sources provide biographical information on individual peers. The principal source used in the preparation of this Library Note was *The Harvester Biographical Dictionary of Life Peers* (1991), compiled by W. D. Rubenstein, which gives detailed information on the 562 life peers and 30 Law Lords created between 1958 and 1990. Other sources used include *The London Gazette*, *Dod's Parliamentary Companion*, *Vacher's Parliamentary Companion*, *Keesing's Contemporary Archives* and *Keesing's UK Record*, *Who's Who* and *Who Was Who*, *Debrett's People of Today*, and the more recent volumes of the *Dictionary of National Biography*. *The Complete Peerage* (1998) also contains information on the hereditary creations. Much of the information on recently created life peers was gleaned from the profiles of new peers published in *The House Magazine*. *Twentieth-Century British Political Facts 1900–2000* and *Whitaker's Almanack* were used to double-check the dates of particular events, and the House of Lords Information Office web pages provided information on party allegiances and dates of death for recently deceased peers. Information on the work of the Appointments Commission and its nominees was taken from the Commission's website, and from its *Report on First Term, 2000–2003*. The final list was cross-checked against a chronological list of peerage creations supplied by the Lords Information Office. A full set of references for the sources consulted is given in Part 5 of this Library Note.

For each peer created since 1958, the following information was collected:

- Title
- Full name
- Gender
- Date of announcement of peerage
- Age at announcement of peerage
- Prime Minister in office at announcement
- Party in power at announcement
- Type of honours list
- Type of peer (life, hereditary or law)
- Party allegiance at creation
- Party allegiance now or at death
- Whether former MP or MEP
- Background (most significant occupation or activity)
- Whether deceased.

This information was then entered into a spreadsheet to facilitate further analysis.

Further details of the methods used to determine the various pieces of information listed above are given below.

3.1 Date of announcement of peerage

The date recorded is the date of the announcement of the peerage creation, as indicated in *The London Gazette*, rather than the date of letters patent or the date of introduction in the House of Lords. This makes it easier to determine the type of honours list in which the announcement was made (see below). There is however an exception to this approach. Lords of Appeal in Ordinary created under the Appellate Jurisdiction Act 1876 are always appointed on an *ad hoc* basis as the need arises and are not announced in any honours list. The date given for such Law Lords is therefore the date when the letters patent were issued, rather than the date of the original announcement.

There have been three cases since 1958 where persons included in honours lists were not subsequently created peers. John Emerson Harding Davies, whose peerage was announced in the Queen's Birthday List on 26th June 1979, died on 4th July 1979 before his letters patent were issued. Dame Shelagh Roberts, who was included in the New Year's Honours List on 31st December 1991, also died before any title was gazetted. In addition, Sir Ian MacDonald Horobin, whose peerage was announced in the multiple list on 29th March 1962, subsequently withdrew his acceptance. These three individuals are not included in the analyses and lists below.

On 10th June 1998 it was announced that Sir David English, who had died that day, was to have been included in the Queen's Birthday Honours List on 13th June 1998. The honours list itself did not mention this fact.

3.2 Prime Minister in office at announcement

In some cases peerage creations recommended by a Prime Minister are not announced until after he or she has left office. For example, John Major's resignation honours list was not published until 1st August 1997, some three months into Mr. Blair's premiership. It is important to note, therefore, that the "Prime Minister at announcement" is not necessarily the Prime Minister who recommended the creation.

3.3 Type of honours list

Peerages are announced on various occasions. Perhaps the best known are the New Year and Queen's Birthday Honours Lists. The former now normally appear on 31st December each year and the latter in mid-June. In the analyses in Part 4 of this Library Note, these two forms of list are combined into a single category. Only a minority of peerage creations is announced on these two occasions, however. Peerages are also announced following the dissolution of Parliament and the calling of a General Election ("Dissolution Honours Lists"), and following the resignation or retirement of a Prime Minister ("Resignation Honours Lists"). On certain occasions combined Resignation and Dissolution Honours Lists have been published (for example, Sir Alec Douglas-Home's on 1st December 1964). These two forms of honours list have been combined into a single category in the analyses in Part 4 of this Library Note.

There have also been numerous announcements of multiple peerage creations outside the usual occasions outlined above. Indeed, the first batch of life peers in 1958 was announced in such a list. In recent years the announcement of lists of what have become known as "working peers" (generally, peers nominated by party) seems to have become a convention, although it is by no means clear when the practice became fully established.

The Harvester Biographical Dictionary of Life Peers suggests that the announcement of lists of "working peers" on a regular basis became an established convention in the late 1960s. The reports on multiple peerage announcements from 1958 to 1970 in *Keesing's Contemporary Archives* do, in most cases, mention prior consultations with Opposition leaders. Some of the reports also state explicitly that the purpose was to strengthen parties' numbers in the House of Lords. It appears that Hugh Gaitskell's nominees in the first batch of life peers announced in July 1958 were included solely to strengthen the Opposition benches. However, it is not clear whether it would be correct to refer to all multiple lists announced since 1958 as lists of "working peers".

In reply to a parliamentary question in 1992 on “working peers”, the then Leader of the House, Lord Wakeham, said:

I do not believe that the House or our constitution recognises the term “working Peer” as a separate category. Certain categories of Peer, however, have been created with the purpose of strengthening the political parties in this House.

(*HL Hansard*, 7th July 1992, col. 1057)

For this reason, such lists are referred to in this Library Note as “multiple” rather than “working” peerage lists.

Life peerages are also announced on an *ad hoc* basis apart from any honours list. This can be for various reasons. *Ad hoc* creations frequently occur when a new minister is appointed to the House of Lords (for example Lord Simon of Highbury, Lord Falconer of Thoroton and Lord Macdonald of Tradeston), and customarily following the retirement of an Archbishop of Canterbury or York. As noted above, Lords of Appeal in Ordinary created under the Appellate Jurisdiction Act 1876 are always appointed as the need arises. The special honours lists announced following the Falklands and Gulf Wars have also been classified as *ad hoc* announcements.

3.4 House of Lords Act 1999

The House of Lords Act, which removed the right of all but 92 hereditary peers to sit in the House, has given rise to a number of issues regarding peerage creations. Before the Act received Royal Assent on 11th November 1999, the honours list of 2nd November 1999 announced that the following hereditary peers would be given life peerages:

Lord Aldington
Lord Belstead
Lord Carrington
Viscount Cranborne
Lord Erroll of Hale
Earl Jellicoe
Earl of Longford
Lord Shepherd
Earl of Snowdon
Lord Windlesham

Lord Aldington, Lord Erroll of Hale and the Earl of Snowdon were hereditary peers created after 1958 (and therefore already feature in the data). The other seven peers were all former Leaders of the House. Despite the particular circumstances surrounding these peerage creations, they have been categorised as “multiple” for the purposes of the analyses in Part 4 of this Library Note. The list of “working peers” announced on 31st March 2000 included seven hereditary peers who had been excluded from the House under the terms of the 1999 Act, all of whose hereditary peerages pre-date 1958. Again, these are included in the “multiple” category.

The 92 hereditary members excepted under the House of Lords Act 1999 are not treated as “new creations”, and thus do not appear in that capacity in the analyses in Part 4 of this Library Note, or the list in Appendix 1. This is true for the 92 who were initially elected to remain in the House, as well as for those who have “returned” to the House following deaths occurring among the 92. This latter group include Lords Cobbold and Chorley, who, as runners-up in the original election, returned to the House following the deaths of Baroness Wharton and the Earl of Carnarvon in accordance with Standing

Order 9. It also includes the following peers, who have subsequently been selected through by-elections under Standing Order 10:

Viscount Ullswater
Lord Grantchester
Viscount Trenchard
Earl of Glasgow
Lord De Mauley
Viscount Eccles
Viscount Montgomery of Alamein
Earl Cathcart
Earl of Stair

While to some extent these may resemble “new creations”, they were not recommended and appointed in the same way as those given life peerages.

Five of the existing 92 have inherited peerages which were created after 1958, and thus the peers of first creation are included in the data. They are Lord Cobbold, Lord Crathorne, Viscount Eccles, Lord Inglewood, and Viscount Slim.

3.5 Appointments Commission and Prime Ministerial nominations

In May 2000 the then Prime Minister announced the establishment of a non-statutory Appointments Commission to assist with nominations to the House during its “transitional” phase following the House of Lords Act 1999. The Commission, chaired by Lord Stevenson of Coddenham, took the form of an independent, advisory, non-departmental public body, and its remit included the recommendation of people for appointment as non-party-political peers. Following a nominations process, on 26th April 2001 the first 15 life peers to be created under these arrangements were announced. Since then, a further 32 peerages have been created in this way.

There is an argument for treating these peers as distinct from other “multiple” lists, given that they owe their membership of the House to a distinctive, non-party-political selection process. The initial reaction in the media to these appointments, and their being labelled “people’s peers”, might appear to confirm their distinctiveness. On the other hand, the Appointments Commission’s criteria required nominees to have the ability and time to contribute to the work of the House, and the Commission expressed the hope that they would indeed make a contribution in their area of expertise. Thus these peers might be considered “working peers”, albeit independent of the political parties. Given these considerations, where relevant the tables in Part 4 of this Library Note indicate peers nominated by the Appointments Commission.

Outside of the Appointments Commission nominations process, Tony Blair announced that he would continue to nominate some non-party-political peers on an *ad hoc* basis:

The House of Lords Appointments Commission is responsible for recommending non-party-political appointments to the House of Lords. However, I continue to nominate direct to Her Majesty the Queen a limited number of distinguished public servants on retirement. I have decided that the number of appointments covered under this arrangement will not exceed ten in any one Parliament.

(*HC Hansard*, 25th January 2005, col. 10WS)

Peers appointed in this way are categorised as “*ad hoc*” creations for Part 4 of this Library Note. To date, these are:

3.6 Type of peerage

All peers created under the Appellate Jurisdiction Act 1876 are categorised under the heading “law”. However, not all Lords of Appeal were created under the 1876 Act. For example, Lord Hope of Craighead, a Lord of Appeal in Ordinary from 1996, was previously created a life peer in 1995 and is therefore included in the “life” category. Similarly, Lord (later Viscount) Dilhorne, who served as a Lord of Appeal in Ordinary from 1969 to 1980, is recorded as an hereditary peer.

Some hereditary peers created after 1958 were subsequently advanced in rank (Lord Dilhorne, for example). These subsequent advancements are not counted as separate creations.

The peerages are baronies unless otherwise indicated. “D” denotes a dukedom, “E” an earldom, and “V” a viscountcy.

3.7 Party allegiance

Official lists of party allegiances only became readily available in the early 1980s. For earlier years, information on party allegiance is available for most of the peers created since 1958 from the quarterly editions of *Vacher’s Parliamentary Companion*. The information given in *Vacher’s* is however by no means complete. In some cases, it is possible to determine political allegiance by looking at an individual’s involvement in political activities immediately prior to or following ennoblement. Where there is any doubt about a peer’s party allegiance, however, he or she is categorised as “independent, crossbench or other”. In a significant number of cases peers have changed party allegiances during their time in the Lords. Party allegiance now or at death was therefore recorded in addition to party allegiance at creation.

3.8 Professional background

There is no straightforward way to classify peers according to their occupation or professional background. The biographical information available is sometimes incomplete. Moreover, many peers have had varied careers and it is not always evident which career, if any, should be given prominence. It was decided to categorise peers according to their *most significant occupation or activity in the decade preceding ennoblement*. This approach does on occasion result in individuals being classified in a way other than might be expected, but it nevertheless means that classification is approached in a consistent way. It is however impossible to classify individuals in a completely objective way, and in some cases a judgement about the relative significance of different occupations or activities has had to be made.

A classification comprising 19 categories was used. The categories were chosen partly on the basis of the information likely to be available and partly on the basis of previous analyses of peers' occupations (see Donald Shell, *The House of Lords*, 2nd ed., 1992, p. 46; Nicholas Baldwin, 'The Membership of the House', in Donald Shell and David Beamish (eds.), *The House of Lords at Work: A Study based on the 1988–89 Session*, 1993, p. 37). The categories used are as follows:

Finance	Banking, insurance, accountancy etc.
Industry	Senior position in the manufacturing or service industries
Media	Senior executive position in television, radio, newspapers, publishing, advertising, public relations or other media organisation
Land etc.	Landowner or farmer
Academic	Academic (including scientists but excluding those specialising in law or engineering etc. – see below)
Teaching	Teacher or other worker in the education sector (not higher education)
Medical	Medicine, nursing and associated professions
Military	Serving member of the regular armed forces
Civil Service	Senior diplomat or civil servant
Legal	Judge, solicitor, barrister, or academic specialising in law
Journalism etc.	Journalist, writer or broadcaster
Engineer etc.	Engineer, architect, surveyor or similar (or academic specialising in these areas)
Arts	Musician, or visual and performing arts
Voluntary	Voluntary or charitable work
Trade union	Trade unionist

Local Government	Local politics or administration
Other public sector	Public sector position not covered above (includes membership of quangos)
Politics	Member of Parliament or involved in political activity (but not at a local level only)
Other	Miscellaneous (including widows of prominent persons, and retiring senior church figures) or no stated occupation or activity

Chart 1: Peerage creations by age at announcement, 1958–2008




Chart 2: Peerage creations by gender, 1958–2008


