MPs who have withdrawn from the Commons Chamber or who have been suspended by the House

This note lists MPs who have left the Chamber voluntarily, been asked to withdraw, or who have been suspended. There are two main avenues which may lead to the suspension of a Member. The first is for misbehaviour in the chamber. The second is where a Member has been found to have broken the [Code of Conduct for Members](#) or committed a contempt of Parliament.

The Speaker is responsible for keeping order in the Chamber and in Committees and if Members disregard the authority of the Chair, he can ask the Member to voluntarily leave the Chamber for the remainder of the day's sitting. This request is not governed by [Standing Orders](#) and the MP can stay on the parliamentary estate and take part in Divisions. Should the Member refuse to comply with this request the Speaker can invoke **SO No. 43:**

43. The Speaker, or the chair, shall order any Member or Members whose conduct is grossly disorderly to withdraw immediately from the House during the remainder of that day's sitting; and the Serjeant at Arms shall act on such orders as he may receive from the chair in pursuance of this order. But if on any occasion the Speaker, or the chair, deems that his powers under the previous provisions of this order are inadequate, he may name such Member or Members, in which event the same procedure shall be followed as is prescribed by Standing Order No. 44 (Order in debate).

This requires the Member to leave the parliamentary estate for the remainder of that day's sitting. If this order is disregarded, the MP can be named under **SO No. 44:**

44.—(1) Whenever a Member shall have been named by the Speaker, or by the chair, immediately after the commission of the offence of disregarding the authority of the chair, or of persistently and wilfully obstructing the business of the House by abusing the rules of the House or otherwise, then if the offence has been committed by such Member in the House, the Speaker shall forthwith put the question, on a motion being made, 'That such Member be suspended from the service of the House.'

Where a Member is found to have broken the Code of Conduct or committed a contempt, the Standards Committee (previously the Standards and Privileges Committee) may recommend a period of suspension, which leads to a motion in the House. Notes:

1. Salary: Since the passing of Standing Order 45A in 1998, the withholding of a Member's salary has been an automatic consequence of suspension. Prior to that, those Members listed here who were suspended for order offences did not lose their salary while those suspended for other reasons (7 March 1990, 20 April 1995, 30 October 1997) did so. In the case of 20 April 1988, the Member was suspended and "...held responsible for the damage that was sustained by the mace."

1a. Salary: Motion provided for Mr Paisley's salary to be withdrawn for 30 days rather than 30 sitting days.

2. Two research assistants were suspended following unauthorised disclosure of a select committee paper. See HC Deb 8 June 2009 c529-

3. The numbering of Standing Orders have changed over time as new SOs have been introduced.

4. The House agreed new Standing Orders on 12 March 2012 splitting the Standards and Privilege into two; The Committee on Standards was established on 7 January 2013.
